#### Introduction

Europe Air Sports (EAS), established in 1988, is the competent organisation for all air sports in Europe representing the interests of its members with all relevant legal bodies at EU level, especially the European Aviation Safety Agency EASA, Eurocontrol and the three EU institutions, the European Parliament, the European Council and the European Commission. Around 700 000 active aviators are organized in the national aero clubs and pan –European air sports organizations who are members of Europe Air Sports. EAS is managed by a President and his board, nominated Technical officers and selected experts who all are volunteers. A partially paid political advisor and part time Programme Manager support the work of the volunteers.

The present Programme Manager will retire in 2018 after 8 years in the job. EAS is seeking for a part-time highly motivated successor who can takeover preferably in March 2018 with a solid overlap period with the present postholder.
